

Authorised Common Contractual Funds

Investment Funds, Companies and Miscellaneous Provisions Act, 2005

Under the powers conferred on it by the Investment Funds, Companies and Miscellaneous Provisions Act, 2005 (the "Act"), the following Alternative Investment Funds (AIFs) have been authorised by the Central Bank of Ireland as common contractual funds.

The authorisation of a common contractual fund by the Central Bank shall not constitute a warranty by the Central Bank as to the performance of the common contractual and the Central Bank shall not be liable for the performance or default of the common contractual fund. Authorisation of a common contractual fund does not constitute a warranty by the Central Bank as to the credit worthiness or financial standing of the various parties to a common contractual fund.
